Issues and Action:

Teresa McKeeman presented the research that the Issues and Action group did on each of the proposed CFUW resolutions. Each was judged on 5 attributes:

1. Does the resolution reflect the purposes and interests of CFUW?
2. Will it stand the test of time?
3. Does it reflect a national or international problem?
4. Is the Background well-researched, accurate and up to date?
5. Is the resolution the logical conclusion of a complete study of the topic?

Although we did not have a quorum to get an idea of how the vote would go at the May AGM each resolution was read and recommendation was presented.

Resolution 1: Chrysotile asbestos and Canada's responsibility in the international trade of hazardous substances - CFUW Oakville. Recommendation: Vote in support. 26 CFUW Guelph members supported this recommendation.

Resolution 2: The funding of aboriginal education. - National Education Committee. Recommendation: Vote against. 29 CFUW supported this recommendation.

Resolution 3: Mobilizing the will to intervene. - CFUW International Relations Committee. Recommendation: Vote in support. 30 CFUW Guelph members supported this recommendation.

Resolution 4: Prostitution of women and children - CFUW Vancouver. Recommendation: Vote against. 32 CFUW Guelph members supported this recommendation.

Resolution 5: Protecting Canadians from the health hazards associated with exposure to electro-magnetic fields from high voltage overhead power lines. - CFUW South Delta, BC. Recommendation: Vote against. 32 CFUW Guelph members supported this recommendation.

Treasurer:

Elaine again presented possible options for a potential 2010/2011 budget.

Discussion was opened to the floor, all comments and suggestions were welcome.

The following discussion came from the floor:

Q - What are reserves used for?

A - If there is a large unbudgeted expense which arises though the year; to pay off any committed expenses should the club disband; to use for expenses which will be reimbursed (\$500 deposit for banquet).

Q - What are our fixed costs?

A - Church rental, plane ticket and registration for CFUW AGM ~ \$2,500. Currently we have \$8,000 in reserves.

Q - How much did the club donate toward Scientists in Schools?

A - ~\$2,000.

- do we want to use a portion of the reserves not for operating costs but use a chunk for a special project or donate to the scholarship endowment fund or to increase member services?
 - There is no point in raising dues in order to build our reserve.
 - Lets get an increase in our membership by raising dues and putting more money in to outreach projects.
 - There is a fear that if we raise the dues we will in fact lose members.
 - Lets lock a portion of the reserves in to a 3 year term and use interest for our operating budget.
 - Lets raise the fee by \$10 which will give us about \$600 for the reserve fund which the executive can use as a buffer should some great promotional opportunities present themselves through the year.
 - Are we shooting ourselves in the foot if we don't raise the dues, we will just have to raise them by more in a few years?
 - We should only increase the \$5 that we are giving to the scholarship committee.
 - If we raise the dues, we would be foolish not to also increase the scholarship committee donation.
 - We should not raise the dues over \$99.
 - We don't know if the decrease in membership is directly linked to the increase in fees. If that is the case, those members likely were not members who were committed to the club and attending monthly general meetings-which are the types of members we want to join.
- A motion will be presented at the April General Meeting for the budget, and voted on at the May Banquet.**
